SHORTFALL PLACEMENT

GTI Resources Ltd (GTI) is pleased to advise that a placement of 7 million ordinary fully paid shares at an issue price of 2 cents per share has been completed. The placement forms part of the shortfall from the Share Purchase Plan which closed on 30 April 2014 (SPP Shortfall).

The placement of the SPP Shortfall was made to institutional and sophisticated Investors and raised gross proceeds of \$140,000. The issue price of the SPP Shortfall was on the same terms as offered to shareholders under the SPP.

Funds raised from the SPP Shortfall will be used for working capital purposes particularly in respect to advancing the Indonesian nickel opportunity the Company is investigating.

The SPP Shortfall was made in accordance with Section 7 of the Information Memorandum of the Share Purchase Plan offer dated 27 March 2014.
