Please find enclosed an Appendix 3B in relation to the issue of 50,000,000 unlisted options in GTI Resources Ltd (Company), exercisable at 8 cents each on or before 30 June 2021, as approved by shareholders at the general meeting of the Company held on 16 May 2017.

Approval had also been given at the general meeting held on 16 May 2017 for the issue of performance rights which would include a vesting condition that the acquisition by the Company of the gold rights to the Windarra tailings dams located in Laverton, Western Australia be completed. The Company announced on 30 May 2017 that it had elected not exercise its option to acquire the gold rights to the Windarra tailings dams. Accordingly, the performance rights will not be issued by the Company.

The Company confirms that the options are convertible into a class of securities quoted on the Australian Securities Exchange. The options were issued without disclosure to investors under Part 6D.2, in reliance on Section 708A(5) of the Corporations Act 2001.
